

CCRG: Chair's Report: AGM 5 July 2021

Our 2020 AGM was deferred several times due to Covid lock downs but we have been fortunate that Auckland has been through the first half of 2021 without a lock down. We have now been able to return to our required AGM date around mid-year so the Chair's report for this agenda covers just six months.

The major issues for CCRG this year is how Auckland Council's budgetary constraints have impacted on a wide range of both capital and maintenance programs across the region, and more specifically in the city centre.

These include a large number of City Centre Targeted Rate projects being put on hold for 2-3 years, and no conversations yet as to when they might be re-instated. ACCAB agendas have been limited to one or two items and replaced with a range of workshops and on-line discussions/forums. Viv Beck resigned as Chair and the former Deputy Chair, Andrew Gaukrodger, was elected unopposed as Chair.

The most contentious issue foor 2021 has been the ongoing saga over Waihorotiu/Queen Street Valley and the unsatisfactory state of the temporary works. This eventually resulted in a threatened legal challenge from business interests which was supported by Heart of the City. In turn, this has resulted in Council staff working with the business community to arrive at an agreed position. CCRG have serious concerns about some of these proposals – see details further on in this report.

A range of submissions have been made and these are available on the CCRG website. The Chair's report for the AGM this year focusses on the Outcome of the City Centre Master Plan and how CCRG can contribute to their achievement.

Sustainable City Centre This outcome aims to shape our approach to transport, air quality, water quality and climate change in the city centre. It focuses on the Auckland Climate Action Framework and Outcome 5 of the Auckland Plan 2050. CCRG Planning Programme

Making these aspects of CCRG work well for us needs to be the focus of the upcoming committee. Since our AGM on 9 November 2020, I have attended 50 meetings related to the CCRG Chair's role and the Deputy Chair will have attended much the same number.

Committee Structure

To achieve our Planning Programme, we really need to organize committee roles around these functional areas. On that basis, the following five roles are recommended for the 2021/2022 CCRG year –



Chairperson – primary roles are our relationships with the Auckland Council family and meeting structure. **Deputy Chairperson** – primary roles are to support/deputise for the chair and communication with members. **Secretary** – primary roles are to prepare agendas/minutes and organize events.

Treasurer – primary roles are to keep accurate financial records and recommend revenue generating activities. **Media** – primary role is to prepare media releases for Chair/Deputy Chair and organize corporate events to promote CCRG.

CCRG Position Statements

The following are our current Position Statements based on the Auckland Plan, and no changes are recommended for the coming year.

Belonging and Participating

The city centre is our home, it is where we belong, participate, eat, play and recreate - we are therefore the most vested in building a world class space for all.

Māori Identity and Wellbeing

CCRG will actively support the integration of Māori values into council planning, decision-making and delivery.

Homes and Places

Quality homes and great public spaces are the identifiers of cities – these are the places we all enjoy, remember, photograph, meet others, relax and play in, irrespective of which city we find them.

Transport and Access

CCRG will advocate for safe and reliable access for everyone with pedestrians, cyclists, micro-mobility, public transport, and service delivery having priority for all transport related decisions in the city centre.

Environment and Cultural Heritage

To ensure a healthy environment for all generations Do No Harm is CCRG's first development principle. Auckland's ability to understand, appreciate and celebrate our own, and other cultures and heritage, is the key to our economic future.

Opportunity and Prosperity.

CCRG supports the many learning institutions within the city centre in their lead role as developers of innovation, technology and entrepreneurship that will drive opportunities for all.

Governance

Open and transparent governance practices provide the essential structure that underpins the legitimacy of public sector leadership.

My thanks and appreciation to all of our committee and the many active members who support the work we do. A HUGE thank you to both Adam and Sri for the work they do to keep the wheels turning on much of the CCRG essential processes.

Our focus for the coming year needs to be expanding our resident database and raising revenue. This putreach will enable and drive our advocacy work for city centre residents.

Very constructive discussion are taking place currently on both of these initiatives and a verbal update will be provided on these at the meeting.
